# APPOINTMENT OF HEALTH OFFICER

Attorney Skinner then said it was an Emergency Session called under the Statutes for the emergency that threatens the operation of Government, more particularly, the Health Department. He also stated that the Health Department Board also held their emergency meeting to appoint a Health Officer. State Statute requires approval of that appointment from the County Commissioners for it to take effect. The meeting was posted according to Indiana Statute and lawful in all regards. If the appointment is approved, documents will be signed to send to the State for their certification.

President Phillippe then presented the appointment of Dr. James Heinrich as Health Officer by the Warrick County Board of Health. There was no discussion. Commissioner Dan Saylor made the motion to approve the appointment. Commissioner Bob Johnson seconded the motion. The motion carried 3-0.

### ITEM FOR COMMISSIONER DISCUSSION

Attorney Skinner presented a letter for the Commissioner's approval for the transfer of funds that were paid out of the Health Department funds for the Independent Contractor, Marlin Weisheit, that should have been taken out of the Commissioner's funds. It was an administrative error on instruction to be corrected by the Auditor with a motion from the Commissioners. Commissioner Bob Johnson made the motion for the correction to the accounts. Commissioner Dan Saylor seconded the motion. The motion carried 3-0.
