The Warrick County Council met in regular session in the Warrick County Courthouse, 107 W. Locust Street, Boonville, Indiana.

Attorney Cliff Whitehead and Administrator Krystal Powless were in attendance.

Auditor Michael Dietsch, Chief Deputy Barbi Shelton, and Recording Secretary Kristine Georges attended and recorded the minutes.

Council President, Brad Overton, called the meeting to order at 6:00 PM.

MOMENT OF SILENCE

ROLL CALL

Roll Call showed the following Councilmen present in person: Ron Bacon, Rob Dimmett, Ted Metzger, Brad Overton, Greg Richmond, and Chris Whetstine. Councilman Richard Reid was present and visible via Facetime.

All actions on motions throughout the meeting were done by a roll call vote.

President Overton wanted to call out the historical events that occurred eighty plus years ago and that we are still honored by some of those veterans from Normandy and to remember the sacrifices that they made.

APPROVAL OF MINUTES JUNE 6, 2024 REGULAR MEETING MINUTES

The minutes from the May 2, 2024 Regular Session Meeting were presented. Councilman Greg Richmond made the motion to approve the minutes. Councilman Rob Dimmett seconded the motion. The motion carried 7-0.

President Overton read the following into the minutes:

Grants Department Administrator Debbie Bennett-Stearsman was present to speak to these requests. She first gave a review of the ARPA funds. She then reviewed what monies from the fund could go into 2025-26 and the exceptions. The Audit request is to pay for the next three years of SBOA auditing for 2024-2026. They do not have a direct number, but they need to get something close to the amount. The Contractual Services-Grant is for the administration of the ARPA funds for the next two years at \$75,000.00 a year. This money would come from the ARPA Interest.

Councilman Greg Richmond made the motion to approve. Councilman Ron Bacon seconded the motion. The Council then had discussion.

Councilman Metzger questioned which they had for this to carry it over. Ms. Bennett-Stearsman went over the conditions again as well as the exceptions. The only things that don't require a contract are administration, audit, and legal fees. She is just asking that these be taken out of interest to be carried over. It's not out of ARPA funds. It is ARPA interest. There is \$261,719.00, she believed, in ARPA Interest.

Councilman Reid asked how many years the \$150,000.00 covered. Ms. Bennett-Stearsman said it was for two years. He then asked how many years were signed on contract. Ms. Bennett-Stearsman said it was a roll over unless the amount of money changes was her understanding. He questioned going beyond one year. Ms. Bennett-Stearsman stated that she was not asking for a contract to be signed. She is just asking for the money to be set aside. There was a brief discussion on contractual services, what hasn't been obligated, and why this money is being asked for through to 2026.

Councilman Richmond and Councilman Whetstine both talked about it being a way to set aside money and being an opportunity.

Ms. Bennett-Stearsman went over quarterly reporting to the Treasury.

Debbie Stevens, Warrick County resident, asked how it would be possible to approve this money being set aside without a contract or invoice which is required to keep the money. Ms. Bennett-Stearsman went over how it was able to be set aside as necessary in 2024 without the contract to be used in 2025 and 2026. There was then a brief discussion on the rules and the exceptions. Ms. Stevens also stated that compliance to contracts and grants falls under the duties of the Auditor. Ms. Bennett-Stearsman said that it was going to change and did at the last Commissioner's meeting.

Councilman Greg Richmond had made the motion to approve the additional appropriation. Councilman Ron Bacon seconded the motion. President Overton called for the Roll Call vote. The motion carried 5-2 with Ted Metzger and Rick Reid opposing.

PUBLIC SAFETY

President Overton read the following into the minutes:

County Administrator Heather Soberg spoke to this request. She said they are still incurring bills for the project and this will cover those bills until the bond is done and can be replenished, which they are looking to complete in July. Councilman Ron Bacon made a motion to approve. Councilman Rob Dimmett seconded the motion. There was no more discussion. The motion carried 7-0.

RESOLUTION TO AUTHORIZE CREDIT CARD PAYMENTS FOR ANIMAL CONTROL **RESOLUTION 2024-07**

Ms. Soberg also presented for Animal Control. She said, with the change of putting Animal Control under the Commissioners, they lost the ability to collect funds onsite. They can't be a collection site without the authorization of the Council. They need to establish an account for the fees and fines they collect and be able to use credit cards. This resolution will allow them to do that. Councilman Ted Metzger made the motion to approve. Councilman Rob Dimmett seconded the motion. The motion carried 6-1 with Councilman Rick Reid opposing.

WARRICK COUNTY COUNCIL RESOLUTION NO. 2024 - 07

RESOLUTION OF THE WARRICK COUNTY COUNCIL AUTHORIZING THE WARRICK COUNTY ANIMAL CONTROL TO ACCEPT PAYMENTS BY BANK CARD AND CREDIT CARD

WHEREAS, Indiana Code § 36-1-8-11(c) allows a payment to be made to a public subdivision by any of the following financial instruments that he fiscal body of the political subdivision authorizes for use: (1) Cash; (2) Check; (3) Bank draft; (4) Money order; (5) Bank card or credit card, as defined by Indiana Code § 36-1-8-11(b); (5) Electronic funds transfer; and (6) Any other financial instrument authorized by the fiscal body;

WHEREAS. Indiana Code § 36-1-8-11(d) provides ethat if there is a charge to the political subdivision for the use of a financial instrument, the political subdivision may collect a sum equal to the amount of the charge from the person who uses the financial instrument;

WHEREAS, Indiana Code § 36-1-8-11(e) provides that if authorized by the fiscal body of the political subdivision, the political subdivision may accept payments under this section with a bank card and credit card, under the procedures set forth in Indiana Code § 36-1-8-11. However, the procedure authorized for a particular type of payment must be uniformly applied to all payments of the same type;

WHEREAS, Indiana Code § 36-1-8-11(f) provides that the political subdivision may contract with a bank card and credit card vendor for acceptance of bank cards or credit cards. However, if there is a vendor transaction charge or discount fee, whether billed to the political subdivision charged directly to the political subdivision's account, the political subdivision may collect from the person using the card either or both of the following:

- An official fee that may not exceed the transaction charge or discount fee charged to the political subdivision or municipally owend utility by bank or credit card vendors.
- (2) A reasonable convenience fee: (A) that may not exceed three dollars (\$3.00) and (B) that must be uniform regardless of the bank card or credit card used.

The fees described in subdivisions (1) and (2) may be collected regardless of retail merchant agreements between the bank and credit card vendors that may prohibit such fees. These fees are permitted additional charges under Indiana Code § 24-4.5-3-202;

WHEREAS, the use of bank and credit cards, subject to an appropriate charge for such service, would be valuable to the Warrick County Animal Control ("WCAC") as an additional means to assist in the efficient collection of amounts ordered to be paid to the WCAC; and

WHEREAS, for that reason, the taxpayers of Warrick County will benefit if the WCAC is authorized to accept bank and credit cards, subject to an appropriate charge for such service.

NOW, THEREFORE, BE IT RES	DLVED by the Warrick C	County Council as follows:

Section 1. The WCAC is authorized to accept bank and credit cards for any payment to WCAC; and

Section 2. The WCAC is authorized and directed to charge and collect:

 A sum equal to the amount of the charge from the person who uses the bank card or credit card;

(2) An official fee that may not exceed the transaction charge or discount fee

charged to the WCAC by any bank or credit card vendor; and

(3) The convenience fee of three dollars (\$3.00) for any payment to the WCAC by bank card or credit card.

President Overton read the following into the minutes:

Ms. Soberg also spoke to this request. She said General Supplies through Buildings were the expenses in Animal Control that they have had to date. She was coming back with this to report to the Council and ask for the appropriation as was discussed at previous meetings. Much of it replenishes what was spent on Animal Control out of the Commissioner's budget. She also addressed the Legal Services and all that they have incurred this year. She may have overshot it a little because the current need is a little over \$15,000.00 to cover one month's invoicing outside of the retainer for Find & Hatfield. She will be back next month for more. They have been paying from another line which is being depleted.

President Overton asked if there were any objections to taking everything but Legal Services. There were no objections. He then made a motion to approve everything listed except for the Legal Services for \$25,000.00. He again read everything except Legal Services into the record. Councilman Rob Dimmett seconded the motion. Councilman Bacon asked what Contractual Services for the Animal Control consisted of. Ms. Soberg went over some of the things listed under that line item. Councilman Reid asked about the postage. Council Administrator Powless explained that it was an error on the agenda. There is only one Postage request for \$793.00. The motion carried 7-0.

The Council then discussed the appropriation of Legal Services for \$25,000.00 that was separated out from the Animal Control – Commissioner's list by President Overton. Councilman Greg Richmond made a motion to approve. Councilman Ron Bacon seconded the motion.

President Overton asked if there was any discussion. Councilman Dimmett asked Attorney Whitehead if this was all legitimate after some of the emails they have received. Attorney Whitehead went over the history of the original request of a \$100,000.00 for Legal Services at a previous meeting which was denied due to timing and other questions. Since then, he posed questions to the County Attorney and he received answers he felt were satisfactory. But then he received additional info via email from a Commissioner which raised questions on this additional appropriation. Attorney Whitehead was hoping that they would be here tonight to explain what it meant. It did call into question whether the Legal Services were for County representation or other representation and would like clarification on the statement.

Ms. Soberg vouched for the validity of the claims needing payment and that she would not send anything for payment that was not appropriate. The Legal Services fees are all for County services and none of it for personal Commissioner legal fees.

President Overton stated as well that he had seen some of the stuff and was okay with everything until other comments were made by email causing questions that he would like addressed before something is done. Ms. Soberg said she was not familiar with the email.

Councilman Richmond stated that he did clarify with the Commissioner in question and the payments were not for a private attorney. He also said that the Commissioner was limited on what he could say right now.

President Overton still feels like it opens them up to issues and he would like to have them resolved. The comments made were in writing. He wants something in writing for the record clarifying it.

Councilman Whetstine stated that he talked to all of the Commissioners and there are no personal expenses in the claims. He said he also talked directly to Commissioner Phillippe on his comments and was assured that no personal expenses were in this request. Councilman Dimmett said his concern was how that would hold up in a court of law and being confident in the vote today. Attorney Whitehead said that hearsay is not admissible. Councilman Whetstine said that the Commissioner addressed him directly and he was comfortable with his answer and it was not hearsay. The Councilmen continued to discuss their thoughts on this.

Councilman Greg Richmond asked Attorney Whitehead if he looked at what was outside the retainer. He said that he looked at everything inside and outside the retainer. Councilman Richmond went over some examples of what would and wouldn't be covered. He feels like the Council is obligated for this. Ms. Soberg said that they were looking at other avenues to try to recoup some of the funds.

President Overton stated that the comments in question were in writing with everything else being hearsay and he struggles with trying to justify his vote on hearsay. Continuing his conversations with the attorney, he felt one realizes

that things need to be in writing and you need to have clarification and it needs to be out so you can refer to that. It needs to be stated clearly.

Councilman Whetstine asked Ms. Soberg whether there were any expenses that are personal for the Commissioners. She said there were not. He then asked what amount would cover the request. She said about \$15,500.00. Councilman Whetstine then asked if any of that was personal for the Commissioners. She said there was not. He then asked the Board whether or not they should approve the \$15,000.00 since they know from the County Administrator that it is good. Councilman Overton said there was already a motion on the floor for \$25,000.00.

Councilman Richmond said he would be glad to amend his motion and asked about the proper procedure to change it. Attorney Whitehead said it was his motion to amend. Councilman Richmond then amended the motion to approve the \$15,000.00 needed instead of the \$25,000.00. Councilman Whetstine seconded the motion. There was another brief discussion between Councilman Dimmett and Attorney Whitehead and his recommendation from a legal standpoint. He would like confirmation from Commissioner Phillippe on some of the questions.

Councilman Whetstine asked Attorney Whitehead if he had seen the invoice for \$15,000.00. Attorney Whitehead said there were no invoices for \$15,000.00 and it was an additional appropriation for a collection of various claims that had been submitted. Some of those have been paid through transfers from other line items. Ms. Soberg clarified that the request was for the current bill that she has on her desk which is approximately \$15,000.00 which she didn't think he had seen yet. Attorney Whitehead then said that the answer is that he cannot vouch for this bill because he hasn't seen it and Commissioner Phillippe's email didn't clarify on which bill. He is not stating whether they should or shouldn't approve anything. He is just stating what he has said and it did raise a lot of questions.

Councilman Bacon wanted to comment that he did contact Commissioner Phillippe and asked him to be here. He was told by Commissioner Phillippe that he couldn't be here. He was going to send a message to his attorneys for them to be here. There was no further discussion.

President Overton called for the vote. The motion failed 2-5 with Ron Bacon, Rob Dimmett, Ted Metzger, Brad Overton, and Rick Reid opposing.

There was a short discussion about Councilman Rick Reid wanting to table the issue. There was nothing to table with the vote failing. Administrator Powless said that something would probably be advertised again for next month.

JOINT RESOLUTION ESTABLISHING GRANT PROCEDURES RESOLUTION 2024-08

All of the Council members received a copy of the Resolution. Attorney Whitehead has also reviewed it and it is ready for approval. Councilman Ron Bacon made a motion to approve the Joint Resolution 2024-08. Councilman Rob Dimmett seconded the motion. Attorney Whitehead wanted to clarify that this was the one passed by the Commissioners and not an earlier version. It was the Commissioner-approved version.

Warrick County citizen, Debbie Stevens, asked to speak. She said there was a comment made earlier that the Council and the Commissioners were changing the role of the Auditor which is a statutory office. Part of that responsibility is compliance to grant and contracts. That office is to vet claims that come through the office for payment and to pull those contracts/grants and make sure everything is paid correctly and terms are met. She questioned the taking away of authority and duties from the Auditor. Attorney Whitehead stated that it was passed by the Commissioners, so it has been before the public once already. He would be happy to share a copy. It doesn't affect anyones statutory duties including the Auditor. There are already have a grant procedure codified by Warrick County in Ordinance 39.12. It just reaffirms most of those that are already in place. Ms. Stevens appreciated his response, but stated that the Commissioners in the past have written Ordinances that were illegal and have tried to circumvent the Auditor's duties. They can't enforce it, but it is still on the record. She wanted to say to this Board that the public depends on Council to do their jobs and work for the taxpayers and not the Commissioners. Otherwise, when money is turned over in lump sum appropriations, the taxpayers lose their line of defense when it comes to spending. She also said that this Board has done that in the past.

President Overton restated the motion made by Councilman Ron Bacon and seconded by Councilman Rob Dimmett to approve Resolution 2024-08. The motion carried 5-2 with Ted Metzger and Rick Reid opposing.

A JOINT RESOLUTION BETWEEN THE BOARD OF COMMISSIONERS OF WARRICK COUNTY AND THE WARRICK COUNTY COUNCIL TO ABIDE BY AND ENFORCE WARRICK COUNTY'S GRANT POLICY

WHEREAS, from time to time, Warrick County ("the County") by and through its departments, applies for and is awarded funding through local, state, and federal grants;

WHEREAS, to insure the County uniformally applies for and uses said grants in compliance with local, state, and federal laws and regulations, the Board of County Commissioners ("the Commissioners") enacted County Ordinance No. 2024-08 ("Grant Ordinance") fully restating Warrick County Ordinance §39.12 effective May 29, 2024; a copy of the County Grant Ordinance is attached hereto as Exhibit A; and

WHEREAS, the Warrick County Council ("the Council") and the Commissioners agree to use their powers to insure the County abides by the policies contained in the Grant Ordinance.

NOW, THEREFORE, BE IT RESOLVED by the Warrick County Commissioners and the Warrick County Council as follows:

Section 1. The Commissioners agree to use their executive powers to enforce the policies contained in the Grant Ordinance.

Section 2. The Council agrees to use its fiscal powers to enforce the policies contained in the Grant Ordinance.
